The Saucon Valley School District (Northampton) has reversed course and will not allow the After School Satan Club to meet in school facilities, saying the club did not adhere to a school board policy requiring all thirdparties to make it clear that the activities were not school-sponsored. The ACLU has threatened to sue.

Township Public Moon Library (Allegheny County) is still feeling the repercussions of their December 2021 promotion of the children's book The Hips on the Drag Queen Go Swish, Swish, Swish. The public outrage was immediate and the township supervisors continue to ask questions about the content of library materials. The head librarian also feels that the December 2021 decision has led to "static township funding."

Norwin School District board (Westmoreland) will be considering the removal of <u>Al</u> <u>Capone Does My Shirts</u> by Gennifer Choldenko, read by fifth graders. Some board members are concerned about sexual innuendos and references to rapists.

CA Governor Gavin Newsome has pledged that the state will boycott **Walgreens** because of its decision not to sell the abortion pill in the twenty states that signed onto a letter telling Walgreens (plus RiteAid and CVS) not to sell the pill in their state.

LGBTQ activist school board refuses to renew an 11-year contract with Arizona **Christian University** (ACU). The decision bans ACU students from serving as student teachers. The most vocal opponent of ACU said she felt that she and the other "queer kids" in her district would be in "personal danger" if they used ACU graduates.

In 2021 a transgender powerlifter sued **USA** 

**Powerlifting** for banning him from competing against women. A Minnesota court ruled that USA Powerlifting had violated the state's antidiscrimination law and must allow him to compete.

Minnesota's governor signed an executive order **making his state a "refuge"** for persons seeking "transgender" surgeries and drugs and the doctors willing to prescribe them.
