A lesbian former assistant director of music and worship at **St. Joseph's University** in Philly is appealing the dismissal of her anti-bias lawsuit against the school. She is requesting in excess of \$150,000 in damages and a court order that the school implement LGBT sensitivity training for its employees.

The Philly Trans March produced the 5<sup>th</sup> annual Philly Black Trans History: A Multigenerational Panel Discussion. One of the panelists was David, Mx Philadelphia Leather, who was asked to comment on "how the leather and kink community can be more inclusive of Black trans people." His response, "They need to let us in."

LGTBQ advocates across PA are asking the state to **modify** the demographic questions asked by COVID vaccine providers include to questions about sexual orientation and gender identity. Currently when it comes to the question of gender, the options are "male, female, unknown".

Murchinson, TX became the 22<sup>nd</sup> city to declare itself a **Sanctuary for the Unborn** and banning abortions. The unanimous decision prohibits abortion within city limits and prevents abortion businesses from opening there.

The ACLU has launched a petition drive to **urge President Biden to issue an Executive Order** "giving trans, non-binary and gender nonconforming people access to accurate IDs." They want the EO to remove the medical letter requirement and add an "X" designation.

It has been confirmed by the Secretary of Defense and Veterans Affairs Secretary that taxpayers will now fund "sex reassignment surgery" for transgenders in the active military as well as veterans.

The recently signed COVID relief bill did not include the Hvde Amendment. thus forcing taxpayers to fund abortion on demand. Also, a provision in the bill could block states from cutting taxes if they accept the money. Depending on how the text is interpreted, the measure could also make it illegal for states to create new tax credit programs used for expanding school choice.
