News From Around PA

The super PAC **American Bridge** is airing anti-Trump ads on PA. It is part of a \$10 million campaign targeting voters in battleground states.

The 12th annual **“Keystone Conference, A Celebration of Gender Diversity”**, is scheduled to be held in Harrisburg March 25-29.

Harrisburg residents are rallying around a **City Council resolution** in support of a proposed state law allowing “undocumented immigrants to have driver’s licenses.”

A federal jury rejected a claim by the **former director of the Gino Merli Veterans Center in Scranton** that he was fired because he is ‘gay.’

A day after an ICE agent arrested an illegal alien at the **Northampton County Courthouse**, the County Executive issued an order stating, “[n] one will be permitted to be arrested in this courthouse by the

federal government without a warrant from a federal judge.”

Four PA teachers are suing the **PA State Education Association** because PSEA continues negotiating provisions to give it “fair share fees” in collective bargaining agreements, despite the US Supreme Court ruling those fees unconstitutional.

News From National Scene

The Alabama Senate voted 22-3 to **ban surgery** and hormone blockers for youths who are confused about their gender. It now goes to the State House.

The **American Psychological Association** (APA) Council of Representatives passed resolutions concerning “sexual and gender diversity among children in schools, discriminatory laws and policies, and LGBTQ parents and children.” The APA, as well as the American Psychiatric Association, were long ago taken over by LGBTQ activists.

In November Colorado voters will be able to vote on a **constitutional amendment**

that would ban abortions after 22 weeks.

Disney’s “Onwards” featuring LGBT couple has worst opening weekend in studio’s history.

Kentucky House passes a measure that would **amend the state’s constitution** to clarify that it does not contain a “right” to abortion and also passed legislation that would strengthen the state attorney general’s ability to investigate the abortion industry.

Democracy Forward filed a lawsuit in federal court on behalf of the Council for Global Equality, Robert F. Kennedy Human Rights, the Center for Health and Gender Equity and the Global Justice Center. They don’t like the Dept. of State’s new Commission on Unalienable Rights stressing “natural law and natural rights.”
