News from Around PA

Pro-abortion **Emily's List** has already made 2024 Congressional endorsements and three of those are PA Congressmen: Matt Cartwright, Susan Wild and Chris Deluzio.

A reply brief to the **Third Circuit Court of Appeals** asking for a permanent injunction to prevent the City of Harrisburg from enforcing its unconstitutional ordinance that has prohibited pro-life volunteers from participating in one-on-one counseling near an abortion facility in the city.

Glen Wilkofsky, **principal timpanist for the Allentown Symphony Orchestra**, has brought a case before the Third Circuit Court of Appeals. As a part of his employment he is forced to pay union dues; dues that are used to support politicians with which he does not agree. In light of the Janus vs AFSCME US Supreme Court decision Wilkosky is questioning why he has to continue paying dues to a union that consistently does not represent his interest.

Over the past six years, Allegheny County has served as a real-world laboratory for testing **AI-driven child welfare tools** that crunch reams of data about local families to try to predict which children are likely to face danger in their homes. Among the factors they have used to calculate a family's risk are race, poverty rates, disability status and family size. New projects with child welfare agencies in Northampton County have been started.

News From National Scene

The **Catalina Foothills High School** in Tucson, AZ has a policy allowing transgender students to change in their preferred locker rooms and telling female students to use alternative facilities if they are uncomfortable.

Arizona Superintendent of Schools Tom Horne launched the "Empower Hotline" for concerned parents to report inappropriate classroom instruction or material in the public schools. Calls to the hotline are investigated to determine if anything, such as critical race theory or gender indoctrination, is detracting from academic instruction.

Florida Governor Ron DeSantis is **terminating the liquor license** of a Miami hotel bar that hosted a "Christmas-themed" drag show for children.

A college student won a lawsuit against **Montana State University** after it dropped a no-contact order against the student over its insistence that she use preferred pronouns. This is the second time in six years that MSU has lost a free speech lawsuit.

First-year students at the **Indiana University School of Medicine** received a "sex and gender primer" lesson that includes instruction on gender being a "social construct," that sex and gender are not the same thing, and on how to be a "more inclusive" health care professional when it comes to "gender diverse patients."
