News From Around PA

Planned Parenthood has been caught lying; claiming that its facility in **Wilkes-Barre** does not do abortions, but recently the center was added to the PA Health Department list of PA abortion facilities.

The PA Dept. of Aging is in the process of developing its State Plan on Aging for 2020-2024. The **Aging Workgroup of the PA Commission on LGBTQ Affairs** is soliciting feedback “on how the next State Plan can better meet the growing needs of LGBTQ older Pennsylvanians.”

Several PA LGBTQ groups signed onto an **open letter to the media and healthcare providers** concerning COVID-19. Their demands included “ensuring health messaging includes information tailored to LGBTQ+ populations” (including imagery of LGBTQ+ persons in graphic ads),

“surveillance efforts capture sexual orientation and gender identity.”

News From National Scene

Inside the cafeteria of the **Marshall Middle School in MN** hangs a variety of flags, including an LGBTQ rainbow flag. A student-circulated petition opposed the flag and requests to display other flags like the Gadsden flag and a banner depicting a heterosexual family were turned down by the school.

Nike, Apple and Microsoft

are among 39 companies that are opposing Alabama’s bill that would prohibit confused youth to get puberty blockers and/or “sex reassignment surgery.” They claim passage of the bill would make “job recruitment” difficult!!

Madison, WI parents

are suing the school district alleging that the Madison school district's transgender policy, part of which allows students to pick new names and pronouns to use at school regardless of whether they have a parent's permission, is unconstitutional because it prohibits teachers/staff from informing parents that their children want to switch sexes.

A federal lawsuit has been filed against the **South Carolina** law that requires public school sex ed classes to only mention heterosexual relationships.

US Senators Josh Hawley and Rick Scott

have introduced a bill banning federal employees from using the Chinese social media app TikTok on their government-issued phones, amid growing national security concerns around the collection and sharing of data on US users.

St. Paul, MN City Council

approved a resolution for “Abortion Providers Appreciation Day”!

US Supreme Court Justice Sonia Sotomayor

has recused herself from a Colorado case involving the Electoral College because of a long-time friendship with one of the parties in the case.
