In 2018 Bryn Mawr College (Montco) removed the name “**M. Carey Thomas**” from school websites, printed materials and even “basic conversation”, but decided to keep the name on the library. Now her name has been removed from that building and it is simply called “Old Library”. She was president from 1894 to 1922, but was also a white supremacist who opposed the hiring of Jewish faculty and the matriculation of black students.

The City of Philadelphia has issued “**Supporting Transitioning Employees: Guidelines for Best Practices.**” Bathroom usage: “coworkers uncomfortable with sharing a restroom with a transgender individual should be the ones asked to travel to a different floor or work area to use the facilities”. HR will pursue punitive actions against those who intentionally misgender or deadname an employee.

News From National Scene

The **Chicago Blackhawks** became the fourth National Hockey League team to say ‘No’ to pride jerseys! The Hawks’ PR department insisted the move was made out of concern for the team’s three Russian players. A new Russian law went into effect in December which makes promoting, praising, or normalizing LGBT relationships illegal.

Wyoming Governor Mark Gordon allowed a **bill barring biological males from female scholastic sports** to become law without his signature. This is the nineteenth state to implement such a law.

The **Christian school in Vermont** that forfeited a game in a girls’ basketball tournament because the opposing team had a biological male player has been banned from future tournaments for “violating the association’s policies on race, gender and disability awareness.”

The University of Helsinki announced it will confer

climate change activist **Greta Thunberg** with an honorary Doctorate of Theology. Recently a Swedish court gave Thunberg and hundreds of other climate activists approval “to proceed with a class action lawsuit against the Swedish state for ‘insufficient climate policy.’”

A lawsuit has been filed in the **U.S. District Court for the District of Rhode Island** against Providence Public School District and its superintendent, Dr. Javier Montanez, for discriminating against Child Evangelism Fellowship by not allowing it to meet on campus while allowing other clubs to meet.

Utah **Governor Spencer Cox** signed a bill into law barring abortion clinics from getting new licenses and banning abortions after 18 weeks.
