News From Around PA

HJ Res 124 - expressing opposition to banning military service by open transgender, passed in the US House with a vote of 238-185. All Dems and 5 GOP voted 'yea.' One of those was Brian Fitzpatrick (R-Bucks).

Philly-based "Truth Wins Out," has coerced Google into removing **Living Hope Ministries** app which helped youth overcome unwanted same-sex attraction.

Reproductive Medicine Associates in Philly has expanded into Allentown and joined forces with NY's Family Equality Council "to expand parenting opportunities for the (LGBT) community."

On Tuesday the **Trans Pride Flag** was raised at Philly's City Hall. It will remain there until April 5th.

Human Rights Campaign, the nation's largest homosexual lobby group, has given these

News From National Scene

The Texas legislature is currently considering several **religious-freedom bills**. A coalition of corporations and business groups including Google, Amazon, IBM oppose the bill saying it gives those with deeply held religious beliefs a "license to discriminate."

In Arizona **K-12 programs dealing with AIDS or HIV** are banned from instruction that "Promotes a homosexual life-style," "Portrays it as a positive alternative life-style," or "Suggests that some methods of sex are safe methods of homosexual sex." Homosexual groups are suing to get the law overturned.

Maryland's Potomac Valley Athletic Conference's LGBT policy forcing biological females to compete against biological males caused **Grace Brethren Christian School** – an independent K–12 school in Prince George's County with approximately 800 students – to expedite its plans to pull out.

A high school student who thinks she is a boy in **MN's Anoka-Hennepin school district** wants to swim on the boys' team. They built her an "enhanced" locker room near the boys' locker room. She's not happy and is suing for discrimination.

Senators Lindsey Graham and Dick Durbin have reintroduced **the DREAM Act**, a mass amnesty bill. Other senators introduced the SECURE Act, which would allow those in the country under Temporary Permanent Status and Deferred Enforced Departure to apply for permanent status.

First Liberty sent a letter to **Transportation Sec. Elaine Chao** alleging that religious discrimination may have taken place during the San Antonio City Council's discussion to block Chick-fil-A from the city's airport.
