News from Around PA

Chelsea Clinton has a children’s book series called **“She Persisted.”** Assistant Secretary for Health to the Department of Health and Human Services, Dr. “Rachel” Levine will be the next “woman” featured in the series! Remember this “woman” was a husband and father of two!

The Young Americans for Freedom (YAF) chapter at **Penn State Harrisburg** has been trying for months to get *Daily Wire* commentator Michael Knowles on campus. University officials have stymied approval of the event by invoking a guideline that allows the school to reject “[a]ny event considered potentially harmful to the public image of Penn State Harrisburg.” YAF legal counsel has sent a letter to the school.

In order to address disruptive behavior and vandalism inside the restaurant, the **Chick-Fil-A in Royersford** (Montco) will no longer allow children under the age of 16

to enter the restaurant unless accompanied by an adult.

News From National Scene

The Indiana House voted 53-54 to bar Indiana University, home of **the Kinsey Institute**, from using any state government money for its sexual research. Here’s some of the problems with Kinsey’s research: he encouraged those he was working with to engage in all types of sexual activity as a form of research, misrepresented single people as married, and hugely overrepresented jailed sex criminals and prostitutes in his data. And . . . one must wonder how he determined the “sexual behavior of children”!

Senators James Lankford (R-Okla.) and Jim Risch (R-Idaho) reintroduced the **Women’s Public Health and Safety Act** that would allow states to exclude abortion businesses like Planned Parenthood from receiving federal Medicaid funds. According to a recent report by the Government Accountability Office, Planned Parenthood received \$1.3 billion in Medicaid reimbursements over the past three years.

A Christian college in Missouri, **College of the Ozarks**, is asking the US Supreme Court to halt a Biden administration directive that requires schools to allow male students to be housed in women-only dormitories and use the girls' showers.

The **American College of Obstetricians and Gynecologists** (ACOG) cancelled the booth of the American Association of Pro-Life Obstetricians and Gynecologists from their annual conference. The group had presented at the medical conference for the past 15 years without issue. ACOG’s views abortion as “an essential component of comprehensive, evidence-based health care” and will work to increase access.
