PA Supreme Court has thrown out the opinion of Commonwealth Court Judge President Mary Hannah Leavitt whose opinion noted that а constitutional amendment would be required to legally allow no-excuse mail-in ballots. Governor Wolf had asked the Democratcontrolled PA Supreme Court to allow no-excuse mail-in ballots to remain in place during litigation.

Both Senators Casey and Toomey voted to confirm **Robert Califf as FDA Commissioner**. He had led the FDA during Obama's last year in office. During that time he dismantled or weakened safety protocols of chemical abortion.

Texas Attorney General Ken Paxton has released a formal opinion concluding that certain "gender reassignment" procedures on children are child abuse. These include castration, the removal of healthy body parts and prescribing pubertyblockers. He stated, "The medical evidence does not demonstrate that children and adolescents benefit from engaging in these irreversible sterilization procedures."

The US Supreme Court has agreed to hear the case of **Colorado-based web designer Lorie Smith. The issue is she** wants to expand to wedding website services; because of her religious beliefs she would have to decline any request from a "same-sex couple" to design a wedding website.

South Dakota Governor Kristi Noem has signed a bill to **protect women's sports.** It is set to go into effect on July 1.

After intense pressure from the church and the community-at-large, West Lafayette, IN city council has voted to remove their proposed ordinance banning talk therapy for minors with gender confusion or unwanted same-sex attraction.

West Virginia House has passed a bill to ban abortion at 15 weeks.
