News From Around PA

Michael Bloomberg is out of the presidential race, but he's not finished yet! He plans to **use some of his \$61 billion to pay for field offices for Joe Biden** in Arizona, Florida, Michigan, North Carolina, Pennsylvania and Wisconsin.

The football players of the **Lackawanna Trail School District** (Wyoming County) had asked their coach if they could pray before games. All went well until a "concerned" parent took a picture of the prayer circle and sent it to the Freedom From Religion Foundation. They fired off a letter to the district and the coach is now forbidden to pray with his players.

For several months in 2016 **Meals on Wheels in Lancaster County** took meals to a blind man who had injured his right leg and twisted his left ankle. After his leg and ankle healed, they stopped providing meals. He

is now suing claiming "anti-LGBT bias" is the real reason.

Recently a **"safe injection" site opened in Philadelphia**. It was closed within 48 hours after protests from area residents who objected to it being located within 500 feet of a school and sharing a space with two day care centers and a senior center.

"But the Lord is with me like a mighty warrior," was written in bold letters inside a locker room at **Letcher County Central High School in Kentucky**. That was until the district received a letter from the Freedom from Religion Foundation on behalf of a "concerned" citizens.

Open homosexual California legislator introduces bill that would **prohibit retail stores from having boys' and girls' aisles**. Stores that don't comply face a \$1,000 fine!

The US Department of Justice filed a "Statement of Interest" in a federal court case involving a **Louisville, KY photographer** who would be forced to participate in same-sex "weddings" against her religious beliefs. The DOJ statement says that the Louisville ordinance, which

contains "sexual orientation" language, violates the US Constitution.

The governor of WV signed a bill into law that **protects babies born alive in botched abortions**.

A Pentagon-funded study of 540 active duty military personnel "concluded" that two-thirds of the US military supports having transgender troops! However, a closer look reveals its bias. The survey was published in "Sexuality Research and Social Policy," which frequently promotes exotic fringe sexual elements in its "work," such as "The Psychology of Kink."
