News from Around PA

Molly Kelly, a Penn State educator is suing the school alleging it twice denied her a promotion because she didn't "demonstrate sufficient ideological commitment to the University's prescribed DEI orthodoxy."

Another "**Dead ICE Agents Can't Kill**" flyer was found at Penn State University. The College Republicans and College Democrats condemned the flyer.

Democrat representatives Mary Jo Daley and La'Tasha Mayes are currently circulating a co-sponsorship memo for a resolution that would recognize May 2026 as "**Sex Ed for All Month**" in Pennsylvania. This effort is being coordinated by the "Sex Education Collaborative and a national coalition of sexual and reproductive health, rights, and justice organizations." (This is EXTREMELY DANGEROUS!!)

Approximately 75 out of 1,400 students at **Central Bucks East High School**

participated in an anti-ICE walkout, met with boos and 'USA' chants from the majority opposing it.

News from National Scene

A California group is pushing the **normalization of polyamory**. Liberal cities and towns in the northwest are passing ordinances to "ban discrimination based on "diverse family structures."

The EEOC has determined that the federal government can bar **transgender employees** from using bathrooms aligned with their gender identity, dismissing an appeal from a "transgender woman" who worked for the US Army.

Texas law bans programs and discussions relating to race, gender identity, and sexual orientation in all public and charter schools from pre-K through 12th grade. The ACLU, Transgender Law Center and Baker McKenzie filed a lawsuit on behalf of the Genders & Sexualities Alliance (GSA) Network, Students Engaged in Advancing Texas, Texas American Federation of Teachers, a teacher, and two students.

The **US Supreme Court** reinstated an injunction blocking the California law that requires teachers to lie to parents if their child is "socially transitioning," at school using a different name, and opposite-sex pronouns.

Boy who identifies as a girl won three events at a **California girls' track meet**. He set a triple jump record - almost six feet longer than that of the second place girl.

A Santa Fe, NM public school counselor has ordered a Christian family's 6-year-old daughter to undergo **reeducation "counseling"** so she will be more accepting of "transgender students". The problem started when a biological male classmate began exposing his genitals to the girls in class, inappropriately touching those girls, and insisting on using the girls' bathrooms.
