There was an attempt to add an amendment to HR 1 -- the federal takeover of the election process -- that would have **allowed 16 year-olds to vote**. It failed by a vote of 126 to 305; however, a majority of Democrats (125 yeas to 108 nays) voted for it! Of PA's congressional delegation Democrats Brendan Boyle and Dwight Evans voted 'yea.'

The **motion to recommit** (in place since 1909) gives a lawmaker in the minority party the ability to request that a bill be referred back to the conference committee. The House GOP have successfully used it since January and 17 freshmen Democrats -- including PA's Chrissy Houlahan and Susan Wild -- have sent a letter to Nancy Pelosi asking her to end the procedure!

Pro-abortion **Emily's List** will be targeting PA Congressmen

Brian Fitzpatrick, Mike Kelly and Scott Perry in 2020, hoping to replace them with pro-abortion congressmen.

Greater Erie Alliance for Equality will hold its LGBTQA Summit at Strong Vincent High School April 12-13. It targets youth ages 12-21.

News From National Scene

Last month the Trump Administration finalized rules concerning **Title X funding**: "clear financial and physical separation between Title X funded projects and programs or facilities where abortion is a method of family planning," ban "referral for abortion as a method of family planning," eliminate a "requirement that Title X providers offer abortion counseling and referral," and require "more complete reporting by grantees about subrecipients and more clarity about informal partnerships with referral agencies." The American Medical Association, Planned Parenthood (PP), 21 states and the District of Columbia have sued the administration over this cut in PP's funding.

Human Rights Campaign Foundation and the National

Education Assoc. sponsored the fourth annual "**Jazz and Friends National Day of School and Community Readings.**" Democrat Reps. Jackie Speier of California and Angie Craig of Minnesota read *I Am Jazz* on the floor of the US House.

The **Girl Scouts Gold Award** -- its highest honor -- recently went to a "reproductive health justice" project to "educate people about and destigmatize access to women's healthcare."

HR 1, **For the People Act**, a bill that would force states to allow early voting, same-day voter registration, etc., has passed the US House with all Democrats voting 'yea' and all Republicans voting 'nay.'

Maryland State House has passed a bill that would allow doctor-assisted suicide. [It now goes to State Senate.](#)
