Parents of students in a **Luzerne County school** report that **Kooth – a web-based counseling program** that was awarded a grant through the Department of Human Services to contract with school districts – was present at an assembly and passing out candy to students to incentivize them to sign up for an account, with an emphasis that they did not have to tell their parents about it.

The US Senate Appropriations Committee released a bill that included \$1 million to go towards renovating the **William Way LGBTQ Community Center in Philadelphia**. The funding was requested by Senators Bob Casey, Jr. and John Fetterman. However, once it was revealed that the center boasted about rooms to try BDSM and sex fetishes and even hosts BDSM and kink parties, Senator Bob Casey removed his support and that line item was removed. Fetterman responded, “This is not the end of this fight and I am going to fight for William Way to secure their funding

in the FY25 appropriations process.”
