News From Around PA

The Center for Tech and Civic Life (CTCL) was founded in 2015. In September and October 2020, they received \$350 million from Facebook's Mark Zuckerberg and his wife Priscilla Chan. According to a recent report issued by Broad + Liberty, approximately \$22 million in total was granted from CTCL to mostly heavily Democrat PA counties. We know these counties received CTCL grants: Armstrong, Berks, Centre, Chester, Dauphin, Delaware, Erie, Juniata, Lancaster, Lehigh, Luzerne, Mercer, Mifflin, Monroe, Montgomery, Northumberland, Philadelphia, Pike, Somerset, Venango, Wayne, and York. Even though CTCL gave grants to "red" counties like Luzerne, which received a grant of just over \$173,000 or 48 cents per registered voter, Philadelphia received a little over \$10 million or \$8.87 per registered voter!! On a raw dollars basis, both Chester and Delaware counties received more from their respective grants than the total doled out to all of the "red" counties combined.

Transgender activist Deja Alvarez has announced a run for State Rep of the 182nd District in 2022. The seat is currently held by Brian Sims who is running for Lt. Governor.

Philly's radical social justice organization GALAEI has a new executive director and programs: Prioritizing Our People (POP); Student Power Leadership & Activism Together (SPLAT); Transgender Intersex Nonbinary Gender-nonconforming Services (TINGS)

News From National Scene

The **Ohio Department of Health** will not appeal a federal court ruling issued in December which found the state's ban on birth certificate gender changes unconstitutional. The department is now working on a process to be implemented by June 1st to allow "transgenders" born in the state to change their birth certificate.

Winners and Losers The losers are those going through so-called "gender-affirmation surgery" - especially the children. The "winners" are Mount Sinai, Transgender Surgery Institute of Southern California, Cedars

Sinai, Moen Surgical Arts, Boston Medical Center, Cleveland Clinic, CNY Cosmetic & Reconstruction Surgery, Plastic Surgery Group Rochester. A recent "Sex Reassignment Surgery Market" report notes that this "market" is growing rapidly because of the "increasing interest of the individuals in this market" and that a High CAGR is forecast for 2021-2027. CAGR is Compound annual growth rate or the rate of return required for an investment to grow.

Montana GOP Governor

Greg Gianforte signed two bills into law: Bill # 1: Allowing parents to opt out of sex ed and ban any provider of abortion services from providing info about sex ed. Bill # 2: requires a transgender to have gender reassignment surgery and petition a court to update their birth certificate.
