News from Around PA

Good Bill: SB 246, which requires parents to be notified of violence or weapons in their child's school, passed in the PA Senate.

Progressive group **Indivisible PA** is calling on Senator John Fetterman to step down.

Department of Education opened an investigation into **University of Pennsylvania's** foreign funding records. UPenn's Sec. 117 foreign funding disclosures submitted to the Department reveals that incomplete, inaccurate, and untimely disclosures may have been submitted.

State and local officials criticized the **University of Pennsylvania** for "capitulating" to the Trump administration by renaming and eliminating references to diversity, equity and inclusion.

Easton City Council unanimously passed a resolution declaring it: AN AFFIRMING CITY FOR LGBTQ+COMMUNITY,

AFFIRMING THOSE MEMBERS RIGHT TO CARE". It also "hereby declares the City of Easton a supportive city for Transgender and Non-Binary people and their families;" and "BE IT FURTHER RESOLVED, that the Council hereby declares the City of Easton a supportive city for Gender-Affirming Healthcare."

News From National Scene
Georgia Governor Brian Kemp signed legislation ensuring that Georgia taxpayers are not paying for transgender surgeries for prisoners.

Tennessee Governor Bill Lee signed legislation into law protecting students, teachers, and school employees from being sued for not using the "preferred pronoun" or for 'deadnaming' transgender students.

Consumer advocacy group **Consumers' Research** has noticed major corporations have dropped DEI – or have they? Major corporations like Walt Disney, Kohl's, Nationwide, Dollar Tree, and UPS have dropped or tweaked the words "diversity, equity and inclusion". The

preferred word is now "belonging."

Lack of store personnel at a **Target unisex changing room** area in Swansea, MA allowed a male to use his cell phone to photograph a teenager as she was nude trying on bathing suits. She saw the camera under the stall and kicked it away, but it was too late, the damage had been done. The 25 year-old perpetrator was later arrested at his home.

Middle and high school students in **Burlington Public School district** (MA) were forced to take a graphic survey about their sex lives. One question fully described anatomy and actions and asked students to share whether they had engaged in any of the explained activities. The question then gave six age options for when the "intercourse" began, starting at age eight.
