Hempfield High School's (Lancaster County) advisor to the GSA (genders sexualities alliance) organized an erotic drag show with professional dancers. It was held at the school after school hours and was announced to all students during second period. Allegedly no permission slips were issued or signed by parents in order for their student to attend. The teacher has since been placed on administrative leave. Were taxpayer dollars used to pay for the dancers?

State Rep Patty Kim (D-103) has announced her support for GLO (formerly Project Silk). It is Harrisburg's first community center created specifically "to serve men who have sex with men and transwomen of color." The drop-in site operates as a "recreational site for youth and young adults ages 14-29 and an STI/HIV testing site".

A women's restroom in the **Perkiomen Middle School** (Montgomery County) has a urinal in it, opening its use to biological males who identify as female!

Eagle View Middle School (Cumberland County) has been circulating literature in support of "gender neutral" bathrooms. "Furries", kids who identify as animals, are also harassing students in the same school.

News From National Scene

Amazon has announced it will reimburse employees up to \$4000 annually when they travel for non-life threatening treatments including abortions. The new policy will apply if such treatment is not available within 100 miles of an employee's home and virtual care is not offered.

In 1992 the late **Derrick Bell**, critical race theory pioneer, published a book Faces at the Bottom of the Well: The Permanence of Racism. The book is a collection of short stories, most of them science fiction-based, yet it is considered a founding text for the CRT movement!

Apple TV's Mother's Day special featuring the characters from the Peanuts comic strip will promote same-sex families. After a discussion about moms with Peppermint Patty, Marcie notes that "some kids have two moms".

According to a team of civil-rights lawyers at the **Rutherford Institute**, police can now legally track citizens through their cell phones – without a warrant. This is the result of the US Supreme Court deciding not to intervene in a lower court decision that authorized such tracking. Courts are ignoring the Fourth Amendment which bans warrantless searches!

The US Supreme Court unanimously ruled that the city of Boston violated the First Amendment by refusing to fly the local Camp Constitution organization's flag. The city had historically given permission to different organizations to fly their flag on the flagpole in front of city hall, but refused to fly Camp Constitution's because it had a big red cross on it!
