Volume 12, Issue 41 November 12, 2022 Printable Remember: versions found online News from Around PA State Senator Steve Santarsiero (D-Bucks County) announced at а press conference that \$630,000 in state funds will be allocated to the Doylestown LGBTQ+ youth center, The Rainbow Room. A second location will be opened in Bucks County.

PA has spent almost \$17 million on "gender affirming care" for minors since 2015, when Governor Tom Wolf took office. He unilaterally changed state policy to cover double mastectomies for minor girls and puberty blockers and cross-sex hormones for children.

Over the objections of HIV advocates, Governor Wolf signed HB 103 into law.

News From National Scene A biological male has been named "Miss Greater Derry 2023". Their website says, "the mission of the organization is to "provide scholarships to young women between the ages of 17 and 24 living in the Greater Derry recognizing area their outstanding achievements in scholastic aptitude, talent, character, community service

and poise within the guidelines of the Miss NH and Miss America Organizations."

Florida Boards of Medicine and Osteopathic Medicine has voted to ban minors from obtaining puberty blockers, cross-sex hormones and gender transition surgeries becoming the fourth state to do so.

Saint Joseph's University's former pilot course titled "Inequality in American Society" was required in the fall of 2021, but the mandate was dropped the following Attendance in the spring. plummeted course and proponents claim this shows the need for it to once again become mandatory!

New Hampshire has just elected the first "transgender man" to a state legislature in the United States. "He" is an abortion advocate and wants teachers to have the ability to teach critical race theory, sexual orientation and gender identity.

Jim Obergefell, the plaintiff in the Obergefell v. Hodges US Supreme Court case which forced same-sex "marriage" on the nation, ran as a

Democrat for the Ohio House of Representatives, losing by 23 percentage points. He spent more than twice as much money than his GOP opponent. Although Obegefell lived several years in DC and spent most of his adult live in Cincinnati, he moved to the more conservative Sandusky in order to run for office. After his loss, he told supporters, "I will continue to fight for the issues that matter the most to our district."

The OH Board of Education has set up a vote on the "Resolution to Support Parents. Schools. and Districts in Rejecting Harmful, Coercive, and Burdensome Gender Identity Policies," expressing opposition to the proposed Title IX changes.
