#### **News From Around PA**

**State Rep Cris Dush** won the Senate seat previously held by retiring Senate Pro-Temp Joe Scarnati.

#### **The GOP won two of the three state-wide row offices.**

Treasurer Joe Torsella became the first incumbent Democrat to lose reelection since 1994 and Republican candidate Timothy DeFoor won the vacant Auditor General seat; the first time the GOP has held that seat since 1992. Incumbent Attorney General Josh Shapiro won re-election with a 51-47 percent lead over Heather Heidelbaugh. The GOP also made gains in the State House and State Senate

House lawmakers in Pennsylvania's General Assembly are demanding a **legislative-led audit** of the 2020 election before the state certifies the results.

**The Pennsylvania State Education Association (PSEA)** wants more schools to shut down and criticizes those that don't go to virtual learning due to COVID-19.

**The State Government Committees** in both the State House and Senate will conduct a thorough review of the November 3<sup>rd</sup> General Election, including holding public hearings in order to instill confidence in the election results.

The former president of the **International Association of LGBTQ+ Judges**, Common Pleas Court Judge Daniel J. Anders, has been promoted to supervising judge of the court's civil division in Philly.

**Campbell Soup Company's** LGBTQ employees' network, Our Pride Employee Network (OPEN), recently participated in a virtual 5K and Fun Run to support Philly's William Way LGBT Community Center.

#### **News From National Scene**

The chairman of the **Federal Elections Commission**, Trey Trainor, said reports of voter fraud in key battleground states are credible. He agrees with the Trump campaign's lawsuits and said their observers were denied

meaningful access. Trainor also said questionable actions by the Democrats may render this election illegitimate.

In an open letter to presumed president-elect Joe Biden, **filmmaker Michael Moore** called on Biden to eliminate the Electoral College and to adopt democratic socialism. He demanded that Biden ignore those on the political right and center and move forward with these progressive policies.

Oregon **voted to legalize** possession of hard drugs including heroin, cocaine, methamphetamines and oxycodone.

More than 100 LGBTQ organizations, elected officials, and community members sent a letter to **NY Governor Andrew Cuomo** urging him to sign a bill that would make all single stall bathrooms gender neutral.
