#### **News From Around PA**

Amanda Green-Hawkins has conceded her **Superior Court** race, even though she was within the half percent margin mandated by law for a recount. Megan King (R ) had 25.41% of the vote, while Green-Hawkins (D) had 25.07% of the vote.

#### **Sixteen-year-old Lebanon County girl who identifies as a boy wants a name change.**

The judge rightly notes, "A significant percentage of children (with gender dysphoria) eventually claim the gender of their birth." The judge also wants to conduct a more comprehensive inquiry to determine whether the young woman understands "all of the implications of gender transformation." His statements are very troubling to LGBTQ activists!

A "transgender woman" (biological male) is suing a Bethlehem **Dunkin' Donuts**

for illegally firing him. He claims coworkers would "misgender her" and that "she" was denied use of the women's restroom in the store. Bethlehem has an "LGBT-inclusive" anti-discrimination ordinance.

**The University of PA** is being sued by a "trans woman" (a biological male) who claims to have been fired illegally. The University had previously filed legal papers stating transgenders are not protected under Title VII. They received pushback from LGBTQ activists and have withdraw that opinion.
