The ACLU has filed a 72-page federal complaint alleging **Central Bucks School District** is engaging in “discrimination” by not promoting LGBT ideology. The complaint alleges the district has created a “hostile” and “toxic” environment for LGBT and “gender non-conforming” students.

Courtney Schreiber, chief of the Division of Family Planning at the University of Pennsylvania and a professor of obstetrics and gynecology at the Perelman School of Medicine, spoke at the PA State Democratic Policy Committee hearing on “Deceptive Practices of Anti-Abortion Centers II”. In essence, she compared the crisis pregnancy centers to terrorist organizations.

Medicaid data shows abortion pill-related emergency room visits have spiked by more than 500%, yet the Food and Drug Administration has approved its use. Recently a lawsuit was filed challenging the FDA’s politically-motivated approval of the abortion drug regimen.

LGBTQ gains in the mid-terms: lesbians were elected governor in Massachusetts and Oregon; openly “gay” Colorado governor Jared Polis easily won re-election; Michigan’s lesbian attorney general won re-election; Connecticut elected its first “gay” treasurer; in the US House – lesbians Rep. Angie Craig (D-MN) and Sharice Davids (D-KS) won re-election; Vermont elected its first lesbian to the US House; California’s 42nd Congressional District and Illinois’ 17th Congressional District will go to “gay” men. New York’s 3rd Congressional District saw two ‘gay’ men running against each other with the ‘gay’ Republican winning. There were 678 LGBTQ candidates on the

ballot on November 8th and 340 won their elections.

Despite backlash from parents’ groups, the **Hilliard City Schools in Columbus, Ohio** will continue to allow teachers to wear badges that say “I’m Here” next to a pride flag, which were supplied by the teachers union. Of major concern is the QR code on the badges which take students to the NEA’s Lesbian, Gay, Bisexual, Transgender, Queer+ Caucus website, which provides adult resources on “coming out” and sexual education.

Planned Parenthood of Central and Western New York

has filed a lawsuit against the town of Henrietta after its board voted against issuing a permit to open a new clinic in a retail plaza.
