News From Around PA

On November 9th **LGBT Equality Alliance of Chester County** will host its fifth-annual Chester County LGBT+ Health Fair at West Chester University. (Question: How honest will they be about the real health risks of engaging in the LGBT lifestyle??)

Behrend University's **Gender and Sexuality Club** will present their 13th Annual Drag Show on November 7th.

By a party-line vote of 15-10 the PA State House Health Committee passed **HB 1890**, a bill that would require healthcare facilities to bury or cremate the remains of aborted babies or those who died due to miscarriage.

The **National Constitution Center** in Philly honored former US Supreme Court Justice Anthony Kennedy during the 2019 Liberty Medal Ceremony. Pro-lifers expressed their views outside

News From National Scene

More than 100 people testified against the change, but the Austin Texas Independent School District board approved a radical new sex-education curriculum for grades 3-8 that encourages all kinds of sex at young ages, urges kids to join LGBT "pride" parades, and aims to redefine biological sex and erase the words "mom" and "dad" from kids' vocabulary.

New Mexico has passed the **Vital Records Modernization Act**, which now gives residents the ability to amend their birth certificates to indicate "Male," "Female" or "X". New Mexico joins California, Washington State, Oregon, New Jersey.

Three girls who claim the **Connecticut Interscholastic Athletic Conference** policy of allowing boys who identify as girls has pushed them out of girls' competition will have their complaint heard by the US Dept. of Education's Office of Civil Rights.

District Court Judge Myron Thompson issued a preliminary injunction

blocking Alabama's Human Life Protection Act from being implemented on November 1

Georgia State Rep Ginny Ehrhart is drafting a bill to make it a felony for doctors to perform "sex reassignment surgery" on minors. It would also ban the prescription of puberty blockers and cross-sex hormones to minors.

New York Governor Andrew Cuomo has signed into state law the federal **Johnson Amendment**, which has been used to silence churches on addressing political issues.

The Kentucky Supreme Court ruled unanimously for the owner of **Hands On Originals**, which had declined to print T-shirts for the 2012 Lexington Pride Festival. The opinion cited the US Supreme Court's recent NIFLA decision which prohibited compelled speech.
