**News from Around PA** LGBTQ activists are upset with the **Philadelphia 76ers** because of their new promotion in partnership with Chick-fil-A.

**HB 103** punishes people with 7 years in prison and \$15,000 in fines for 'expelling' saliva, blood, or another bodily fluid onto a police officer. This law also charges people with a second-degree felony if they knew or 'should have known' they had a communicable disease after transmission to another person. The offense is punishable by up to 10 years in prison and \$25,000 in fines. Governor Wolf has signed it into law, over the objections of the ACLU and LGBTQ activists because "communicable disease" would include HIV. PA is now one of 35 states that criminalize intentionally exposing someone to HIV.

**TD Bank** has donated \$500,000 to a program that performs irreversible so-called "gender change" procedures on minors. The money was paid through Canada's Children's Hospital

Foundations to the McMaster Pediatric Gender Diversity Program in Ontario. Have they donated to PA children's hospitals 'gender diversity' programs?

#### **News From National Scene**

After the mid-term elections, **at least 10% of California's legislators identify publicly as LGBTQ.** It is believed to be the first for any US legislative body. What kind of policies can be expected from them?

The **Geneva Consensus Declaration on Promoting Women's Health and Strengthening the Family** declares there is no international "right" to abortion. It was started in November 2020 and the Trump Administration signed on, but Joe Biden withdrew support, when he took office. Thus far 37 nations have signed onto the document.

In October Arizona Congressman Paul Gosar asked the National Institutes of Health to explore the scientific research behind so-called "Gender Affirming Care" (i.e. puberty blockers, cross-sex hormones and surgeries) for minors. A month later, the

Congressman received a form letter "response" from the acting director of NIH!

A federal judge in Washington state has tossed a lawsuit by **Seattle Pacific University** seeking to stop a state inquiry into the school's hiring practices that block LGBTQ individuals from full-time roles. The Free Methodist USA school voted to keep a policy requiring employees to agree to "lifestyle expectations" that adhere to only heterosexual marriage. Sixteen faculty, staff and students sued the school in state court.
