bisexual Open Jessica Benham won PA House District 36, which covers part of Allegheny County, on election day.

According to the Victory Institute, there are 57 openly LGBTQ individuals holding elected office in PA.

Unanimously passing a prohomosexual ordinance, Crafton Boro became the fifth municipality in Allegheny County to do so. It creates a commission where people can report 'discrimination' and allow the case to go to the Court of Common Pleas. Complaints can include not permitting a man to use a woman's restroom.

News From National Scene In light of sworn affidavits from witnesses who attest to errors and potential fraud, Georgia Governor Brian Kemp has called for an audit of the signatures on ballot envelopes.
