News From Around PA

Governor Wolf admitted on the **KDKA Radio Morning Show** that his wife dropped off his mail-in ballot. However, the law stipulates that the voter must drop off their ballot, unless they have a disability. BUT, again, THE PA Constitution, Article VII, Section 14(a) says only absentee ballots are permissible for certain reasons; it says nothing about permitting no excuse mail-in ballots!! So . . . which has more authority -- the law or the PA Constitution??

PA Congressman Brian Fitzpatrick (PA-1) was one of thirteen GOP US House members to vote for the "Infrastructure" bill. Without their votes, the bill would have failed. Six Democrats voted against it.

PA State Rep Christopher Rabb (D-Philly) plans to introduce a bill that would prohibit using Native American imagery for public school mascots and logos. He

the same state rep who wants to change Columbus Day to Indigenous Peoples' Day, wants to remove cannabis as a highly addictive and dangerous substance and plans to introduce a bill that "will require all inseminators to undergo vasectomies within 6 weeks from having their third child or 40th birthday, whichever comes first".

Transgender Tyler Titus, candidate for Erie County Executive, lost his race to Republican Brenton Davis. However, Titus remains a member of the Erie School Board.

News From National Scene

Washington State Supreme Court declares **Seattle's Union Gospel Mission** must hire someone who does not adhere to their religious beliefs. The applicant is a lawyer who wanted hired in order "to change the Mission's religious beliefs".

Missouri, Arizona, Montana, Arkansas, Iowa, North Dakota, South Dakota, Alaska, New Hampshire and Wyoming, as well as many Christian non-profits (including the national office of the AFA) and conservative for profit organizations have

filed suit **challenging President Biden's mandate** that private businesses with 100 or more employees force their employees to be vaccinated, tested weekly for COVID or be fired. The **Fifth Circuit Court** has just issued a temporary stay finding "grave statutory and constitutional" issues with the mandate.

A September poll from the pro-transgender **Public Religion Research Institute** shows a steep three-year drop in support for boys playing in girls' sports and for the claim that people's 'gender' is unconnected to their biological sex.

Sesame Street and CNN teamed up for a COVID vaccine Town Hall to promote the shot to their young audience. The Sesame Street characters soon began tweeting they had gotten the shot.
