The Pennsylvania Coalition of LGBTQ+ organizations recently held a march and rally at the State Capitol They wanted to make four points:

An employee of Hershey Entertainment and Resorts, has filed a lawsuit in Dauphin County Middle District Court, alleging she was suspended after refusing to escort a "transgender woman" (biological male) to a women's locker room at The Melt Spa. The civil rights lawsuit alleges religious discrimination.

## **News from National Scene**

Australia beat Denver out to host the **2030 "Gay Games"**. The organizers were concerned by the "recent turn toward anti-transgender federal policy (and) left many global leaders wondering if a U.S. city would be a safe destination for the event."

Transgender swimmer Ana Caldas has been penalized with a five-year ban and has been stripped of all competition results between June 2022 and October 2024 by World Aquatics—the international governing body for aquatic sports— for refusing to take a gender verification test.

Stacie-Marie Laughton, a former New Hampshire lawmaker who is believed to be the first elected openly transgender lawmaker in U.S. history, recently pleaded guilty to federal sex abuse charges. He is accused of working with her ex- girlfriend Lindsay Groves to exploit children at a

daycare center called Creative Minds in Massachusetts.

Warnings from conservatives about Paul Thomas Anderson's movie "One Battle After Another". Ben Shapiro says, "You can make excuses for it, but basically the [film is] an apologia for radical left-wing terrorism, that's what it is."

The FBI has severed all ties with the **Southern Poverty Law Center.** FBI Director Kash Patel notes, "The Southern Poverty Law Center long ago abandoned civil rights work and turned into a partisan smear machine.
