News From National Scene

VA Governor Glenn Youngkin (R) overhauled the **state’s transgender policy** for public schools, preventing administrators from hiding children’s gender transition from their parents and affirming parents’ right to “nurture values and beliefs for their own children.”

In response to Governor Youngkin’s actions, **Pride Liberation Project**, a student-run LGBTQ activism group organized a walkout in schools across six northern Virginia counties.

Senator Lindsey Graham (R-SC) has said he will introduce a bill that will **ban abortions after 15 weeks nationwide**. The Democrats call this ‘extreme’, but the US should not be joining North Korea and China in allowing on-demand abortion at all stages of gestation!

MA Governor Charlie Baker has signed a bill that legalizes abortion up to the moment of birth saying he wants “to protect access to reproductive health care services”.

Visa, Mastercard and American Express have announced they will distinguish **firearm-related purchases** from other retail purchases. The International Organization for Standardization, or ISO, approved a “merchant category code” for gun-related purchases. US Senator Elizabeth Warren (D-MA) and NYC Mayor Eric Adams pushed for the move.

After an open homosexual testified against recognizing LGBTQ History Month (and its curriculum), calling it the forced sexualization of students, the Miami-Dade, FL school board voted 8 to 1 to reject observing it!

West Virginia legislature has passed a **near total abortion ban**. A compromise had been reached which clarified the criminal penalties, which take effect in 90 days.
