#### News From Around PA

**The Planned Parenthood in Reading** has announced they will only be open on Tuesday, Wednesday and Fridays for the rest of the year!

On October 22 the State Library of Pennsylvania will “celebrate” LGBT History Month by displaying *The LGBT History Roadshow* in the atrium of the Keystone Building. (Note: This used to simply be “Gay History Month,” until they expanded their indoctrination goals.)

**NW PA Pride Alliance and Identity,** Edinboro University’s LGBTQIA+ student organization, marched in the schools Homecoming Parade.

#### Eastern Lancaster County

**School District** board voted unanimously to implement a \$2.4 million renovation plan to create non-gender specific facilities at its high school. The design of four “zones” will hold a total of 48 private changing rooms and 76 private showers. Why?

Because last schoolyear they allowed a girl who identifies as a boy to use the boys’ facilities and parents complained.

#### Third Circuit Court of Appeals

has ruled that Pittsburgh’s ordinance that set up “no-go” zones around hospitals or health care facilities “ as properly interpreted, does not extend to sidewalk counseling—or any other calm and peaceful one-on-one conversations....” The ordinance had been used to stifle sidewalk counselors outside abortion clinics.

#### News From National Scene

California Governor Gavin Newsome has signed a bill into law mandating that all public colleges and universities **provide abortion drugs for free** to students up to 10 weeks of pregnancy starting Jan. 1, 2023. According to the bill, lawmakers hope to collect about \$10 million in private donations to help campuses set up their abortion practices.

Many college students are in favor of replacing **Columbus Day** with Indigenous Peoples’ Day. In fact, 79 percent of college students support the

idea, according to data and survey analytics company College Pulse.

US District Judge Reed O’Connor **reversed a mandate from the Obama administration** that required a doctor to perform gender transition procedures on any patient, including a child, even if it was against their medical judgement or religious beliefs.

In Louisiana high school **teachers will not get a free lunch from Chick-fil-A** because of the decision of their principal! “Out of respect to our LGBTQ staff, we have chosen to not serve Chick-Fil-A at an employee lunch,” principal Steven Corbett said in a statement. “The #1 rule at Lusher is to ‘Be Kind’ and we live this motto every day.
