Check Our Recent Interview News From Around PA

PA State Senator Tom Killion (R-Chester/Delaware) has introduced **SB 444**, which would add “or intellectual or physical disability” to the PA hate crimes law. However, recently the Senate Majority Policy Committee held a public workshop discussion at Killion’s request to discuss adding “gender identity” and “sexual orientation” to the PA hate crimes law!! If convicted of a hate crime, a five-year sentence would be added.

Montgomery County has issued guidelines for sexual health and practices during the COVID-19 pandemic. Several sections include “If you usually meet your sex partners online or make a living by having sex,” and “If you decide to have sex outside of your circle of contacts or a hook up,” and “If two is company then three (or more) is definitely a crowd.” The guidelines provide judgment-free, medically sound advice to protect people regardless of sexual interaction.” Making a

living by having sex is still against the law -- maybe the Montco Health Department needs reminded of that!!

Remember **all the State House seats and odd-numbered State Senate seats are up for re-election.** In the hopes of flipping the legislature, Philly’s openly homosexual State Rep Malcolm Kenyatta took a five-day drive across PA in his “Flip PA Tour” meeting with 17 Democrat candidates.

Pro-abortion **Emily’s List** has launched a \$1 million effort to flip the PA General Assembly to the Democrats.
