News from Around PA

Despite bipartisan opposition on October 3, 2019, Governor Wolf issued an executive order to unilaterally enter Pennsylvania into the **Regional Greenhouse Gas Initiative (RGGI)**.

Immediately, the Department of Environmental Protection and the Environmental Quality Board promulgated rulemaking for a CO2 Budget Trading Program in the Commonwealth. Now SB 1068 would erase Regional Greenhouse Gas Initiative regulations from PA's books has passed the State Senate by bipartisan vote of 33 to 17.

Mural Arts Philadelphia is having another mural contest for Gay Pride 2026. This one will be located at 1221 St James St. and will "showcase LGBTQ+ trailblazers including Gloria Casarez and other leaders who will be selected throughout the mural creation process."

Jason Landau Goodman, co-founder of the Pennsylvania Youth Congress, a LGBTQ+ lobbying

group, has announced his candidacy for the seat of Democrat Rep. Mary Jo Daley, who currently represents the 148th House District. She has announced she will not run for re-election in 2026.

Did you know: **Rainbow Room** was founded by Marlene Pray in 2002 in Doylestown, north of Philly. A second location opened in Langhorne in April 2023. It has direct ties to Planned Parenthood Keystone.

News from National Scene

Colorado's **Rampart High School** has barred a senior from painting her personal parking space with 'a shepherd on a hill, a staff and a sheep, along with a Bible verse. She was given a second chance and entered '1 Cor 13:4,' along with a new design that 'was otherwise not religious.' She was once again denied and is being represented by First Liberty citing her First Amendment rights to not end at the schoolhouse door.

A Florida teacher at **Talbot Elementary School in Gainesville** has been put on leave after forcing students and faculty to call her "Mx." instead of "Ms." or "Mrs." in

violation of state law. The 2023 law, Florida Statute 1000.071, bans K-12 school employees from using personal titles or pronouns that do not match their biological sex.

In 2023, North Carolina passed SB 49, **the Parental Rights Bill**, which guarantees parents the right to opt out of gender ideology propaganda lessons, allows parents to review school textbooks, and gives parents access to their child's records. George Griffin, the school board president for Chapel Hill-Carrboro City Schools, is openly bragging about his refusal to follow North Carolina law, claiming that the bill was "discriminatory." NC House Majority Leader Brenden Jones announced he will have Griffin testify before the NC House for his blatant violation of state law.
