News From Around PA

Montgomery County's **Borough of North Wales** passed a LGBTQ special rights ordinance by a vote of 7-1. It will impact employment, housing and public accommodations i.e. women's bathrooms will now be open to biological males who identify as female. This becomes the 22nd Montco municipality to pass such.

Three biological males who now identify as female want to throw out the **state's name-change law** which prevents Pennsylvanians convicted of serious felonies from changing their names. Those felonies include murder, rape, voluntary manslaughter, involuntary deviate sexual intercourse, sexual assault, aggravated indecent assault, robbery, aggravated assault, arson and kidnapping. PA's Attorney General Josh Shapiro filed a brief asking the courts to dismiss the case and also noted that two of the plaintiffs had been convicted

of aggravated assault and the other of rape.

Open homosexual Robert Szwajkos, who currently serves on the Newtown Human Relations Committee, is now running for Newtown borough council. He was instrumental in getting Newtown to pass a LGBT special rights ordinance.

University of Pennsylvania students successfully shut down an event on immigration detention and deportation. Their "concern" was the presence of retired ICE director Tom Homan.

The State Library of PA is establishing its first LGBT specific collection. It will not be a "special collection," but according to Director Sarah Greene, "Expanding our LGBT titles will now be an ongoing thing. It should and will be just a normal part of our regular acquisition process."
