Senator Michelle Brooks (R-50) has introduced two bills. One would prohibit third parties from sending out applications for mail-in or absentee ballots which appear to be from the Commonwealth. The other would allow third parties to send reminders or information as to how to obtain mail-in or absentee ballots, but it must boldly note at the top of the document that it is not official and state exactly who is sending the mailer. Additionally it “may not mimic any official capacity, including a return mailing address of any government office, agency or elected official.”

Leigh Chapman, PA’s Acting Secretary of State said it will likely take several days until midterm election results are complete and certified.

News From National Scene

The **American Nurses’ Association** has issued a statement opposing laws or polices that place restrictions on transgender health care or criminalize gender-affirming care. It goes on to say, “The legislative intent and medical claims behind these laws are not grounded in reputable science and conflict with the nurse’s obligation to promote, advocate, and protect the rights, health, and safety of patients.”

The **Bristol, Virginia City Council** voted unanimously to advance a pro-life zoning ordinance that would ban new abortion facilities from opening and restrict the one that is already there from expanding. Tazewell and Russell have recently passed similar ordinances.

A court has ruled that the Christian owner of **Tastries Bakery in California** acted lawfully when she refused to make a wedding cake for a lesbian couple and instead referred them to a different bakery, citing her sincere religious belief that marriage is intended to be between one man and one woman.

According to a district court ruling, **Coach Joe Kennedy** "is to be reinstated to his previous position as assistant coach of the Bremerton, (WA) High School football team" on or before March 15, 2023. It also requires that the school district pays his attorneys' fees and costs. Remember, he was fired for kneeling in prayer after games. Some students joined him and the school said the students were being coerced.

Walt Disney has cast Jaren Kyei Merrell in an upcoming Marvel movie. He is known professionally as Shea Couleé, a celebrity drag queen and a former RuPaul’s Drag Race.
