News From Around PA

Governor Tom Wolf issued an **executive order** which permanently establishes the Department of Environmental Protection's Office of Environmental Justice to be headed by a director appointed by the DEP Secretary. It establishes the Environmental Justice Advisory Board and an Environmental Justice Interagency Council.

PA could raise a billion dollars a year in tax revenue, if they **legalize recreational marijuana**. This is claimed by Senator Sharif Street (D-Philly) and Dan McLaughlin (R-Erie) as they introduced SB 473. But how much will it cost in human lives destroyed??

LGBTQ activist honored during a luncheon at the

State Capital: A citation introduced by State Senator Sharif Street ((D-Philly) was presented to **Franny Price, former executive director of Philly Pride Presents**. This organization planned the Philly Gay Pride Parade/Festival and Outfest, where several years ago Christians were arrested and charged with hate crimes for singing hymns nearby.

The recently formed **PHL Pride Collective** has partnered with the nonprofit GALAEI (the Gay and Lesbian AIDS Education Initiative) to further organize and fundraise to pay for the 2022 Gay Pride Parade. According to their website, GALAEI now identifies as a "Queer and Trans, Black, Indigenous, and People of Color radical social justice organization."

News From National Scene

A **Florida school board member** chaperoned a group of elementary school children on a field trip to a gay bar. But it doesn't sound like this is the first year. The school board member posted on her official school board Facebook page, "The students and I had a fun walk over and learned a lot about our community! A huge thank

you to Rosie's Bar and Grill for hosting this special field trip every year!"

The **National Association of Women Judges** passed a resolution barring future conferences from being held in jurisdictions "where LGBTQ protections are repealed or where discriminatory LGBTQ laws are enacted." Interesting that they passed the resolution in Nashville and Tennessee is now one of the 'forbidden' states!

A federal inmate in Texas is suing to have "**gender affirmation surgery**". The man who identifies as female has recently been moved to a federal women's prison in Fort Worth. No federal inmate has ever undergone sex reassignment surgery. No monetary damages are requested, but the ACLU attorneys are asking court costs and fees.
