News From Around PA

The Democrat-controlled boro council in **Sharpsburg (Allegheny County)** voted down a homosexual special rights ordinance. The four voting 'no' said the ordinance lacked enforcement mechanisms and a statute of limitations for the claims.

The Coalition for Social Equity is targeting your counties They were just successful in getting Bloomsburg Town Council to pass a homosexual special-rights ordinance which impacts employment, housing and public accommodations. The Coalition will work with the Bloomsburg Human Relations Commission to "educate" business owners and community members. If this had been in place in 2014 when two lesbians tried to get the **WW Bridal Boutique** to made them wedding dresses, the lesbians would have been able to file a complaint against the

boutique when the Christian owners refused to make the dresses. Note: the owners have been harassed and maligned so viscosly that they have closed their shop.

Presidential candidate Joe Biden sat down with the *Philadelphia Gay News* and affirmed his support for the LGBTQ community. He said during his first 100 days in office he will work to pass the **Equality Act**, which would add 'sexual orientation and gender identity' to the 1964 Civil Rights Act. He said he will "lead a coalition of like-minded governments and international organizations to **advance protections for LGBTQ+ people.**" He also reiterated that he will **remove all the religious freedom protections** that President Trump has put in place to protect Christian businesses, medical providers and adoption agencies.

The Westover Companies and Woodward Properties, Inc. in Chester County are being sued by a "transgender man of color" (a woman who thinks she's a man), who claims she was subjected to a hostile work environment. She claims fellow employees "misgendered" her and that her apartment was broken into "on account of

discrimination and retaliation." She is seeking more than \$150,000 in damages, annual LGBT sensitivity training for all workers and a "comprehensive antibiotics policy" including SOGI.

News From National Scene

Twitter locked **US Customs and Border Protection Commissioner** Mark Morgan out of his account after he posted about the success of the border wall in keeping criminals out calling the post a "disturbing" threat to national security.

The **Geneva Consensus Declaration** was signed by US and 31 other countries. It further strengthens an ongoing coalition to achieve better health for women, the preservation of human life, support for the family as foundational to a healthy society, and protection of national sovereignty in global politics.
