University of Pennsylvania Students for Justice in Palestine sent out a social media post which offered a tribute to Hassan Nasrallah, the terrorist leader of Hezbollah who was killed by an Israeli airstrike. They plan a “Week of Rage” to mark the one-year anniversary of the October 7th massacre of Israelis by the jihadists.

PA Supreme Court rules 4-3, that voters must write the correct date on their mail-in ballots. This overturns a 4 -1 Commonwealth Court decision. Only Judge Patricia McCullough dissented saying correct dates must be on the ballots.

A black **Gettysburg College** student’s allegation that he had the n-word written on him by a white male wielding a “box cutter” is facing questions from a former federal prosecutor and current law professor who is questioning why the alleged

victim went to the media rather than law enforcement.

Luzerne County Manager Romilda Crocama announced in September there would be no drop boxes used in the November 5th election because of security concerns. After an ACLU lawsuit and a letter from PA’s Democrat Attorney General, the drop boxes will be used.

From National Scene
This week the **World Health Organization** held a meeting entitled “Pandemic prevention and surveillance.” The current administration is trying to use the U.S. membership in WHO as the basis to unilaterally give expansive authority to WHO over anything that has the “potential to impact public health.” Biden/Harris are doing a work around the Constitution by using the word “accord” rather than “treaty” which would require Senate approval.

In 2023 a bill to ban “conversion therapy” failed to pass the Kentucky legislature. Also in 2023 and over the veto of Governor Beshear (D), the legislature voted to protect minors from gender transition hormones

and surgeries. Recently the governor did a work around and issued an executive order banning “conversion therapy” for minors. That means no talk therapy allowed for gender confused minors!

A reporter from the liberal **Atlantic** magazine who has attended many Trump rallies has expressed concern over the fact that the rallies begin in prayer and many of those prayers include quoting II Chronicles 7:14.

In December 2018 teacher Peter Vlaming was fired by the **West Point School Board in Virginia** based on a preferred pronoun policy, which had no religious exemption.
