News from Around PA

A senior at Penn State York, who identifies as pansexual, has created a LGBTQ+ dating app with an “inclusive mission”. Her ultimate goal is to foster a space for “transgender, nonbinary, everybody in between, to have somewhere they can go and feel safe and not discriminated against.”

Next year in Pittsburgh a fertility clinic will be opening that’s “**inclusive of queer and transgender people**”. It is a partnership between Allegheny Reproductive Health Center and Mate Fertility. The clinic will “offer sperm and egg donation, surrogacy services, in vitro fertilization and hormone therapy”.

After 400 students walked out because the board refused to pass a policy keeping boys out of girls’ bathrooms, the **Perkiomen Valley** school board (Montgomery County) had a change of heart and has now passed a policy requiring students to use bathrooms

associated with their biological sex!

State House rules prohibit session from being held prior to 8 a.m. or after 11 p.m. Well, the Democrat-led House Appropriations Committee adopted an amendment (one the committee had just received minutes before) at 11:45 p.m. on October 4th. The amendment would have implemented permanent mail-in voting -- once you requested one you would be placed on a permanent list and have to jump through hoops in order to be taken off the list. It would have expanded voter ID requirements, moved primary election day to March 19th and made other significant changes to our election laws. It was defeated on Thursday by a 117-26 vote – Democrats didn’t want expanded voter ID and GOP didn’t want expanded mail-in voting.
