The **ACLU** has filed a **complaint** with the US DOE Office for Civil Rights and the DOJ's Civil Rights Division on behalf of seven transgender and non-binary students in the Central Bucks School District claiming illegal gender discrimination.

After facing backlash for placing a teacher on administrative leave for not using preferred pronouns, the board of **South Side School District** (Beaver County) held a special vote to remove the policy. They also voted to reinstate Daren Cusato to the school's staff. The board says it plans to write a new preferred pronoun policy.

It has recently been revealed that the current **Acting PA Secretary of Education, Eric Hagarty, as well of Governor Tom Wolf's Deputy Chief of Staff** received emails from the US DOE Office of Communications and Outreach back in August 2021. The emails showed how the Biden Administration would use

school sports and other extra-curricular activities as leverage to "convince" parents that their child must get the COVID vaccine to be allowed to fully participate in school activities.

News From National Scene

USC's Annenberg Inclusion Initiative, which has ties to **Walt Disney Studios**, has announced the "Reproductive Rights Accelerator" program. It will award at least three seniors a \$25,000 grant toward the script development and creation of films about the issue of "abortion rights".

Remember **Jack Phillips of Masterpiece Cakeshop** in Colorado? Well, he's back in court to protect his First Amendment rights. In 2018, the very day the US Supreme Court ruled in his favor over a cake celebrating same-sex 'marriage'. A trans activist called the shop requesting a custom-designed cake, pink on the inside and blue on the outside, that would symbolize and celebrate a gender transition. Phillips declined and was immediately sued!

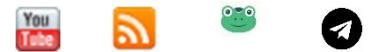
A **Doernbecher Children's Hospital**-produced guide to

"safe tucking," a practice used by those who identify as transgender that "makes the genital area look smoother and flatter" by "moving the penis, testicles, or both out of the way" was passed out at the Burbank Pride Parade. The Portland, OR children's hospital also produces a 'chest binding' guide that involves "wrapping something around your chest to flatten your breasts" in order for a woman to look more masculine.

A California **daycare teacher** was fired allegedly for not reading books about same-sex marriage to young students between the ages of one and five. The center's policy requires all teachers "to support and promote celebrations of 'diversity' including same-sex marriage to children in the program."
