News From Around PA

The **Pennsylvania State University College of Education** has plans to 'reimagine' education at the "regional, state, national, and global levels" to ensure that children are sufficiently literate in specific concepts, including "social justice," and "climate change."

Three new **LGBTQ+ historic markers** have recently been installed in Philadelphia; this now makes it the city with the most LGBTQ+ historic markers in the world!

The nation's largest homosexual lobby group, **Human Rights Campaign PAC**, has endorsed Dr. Tyler Titus for Erie County Executive. If elected in November, Titus will become the only transgender county executive elected in the US.

United Community Church in Erie will be "celebrating" its thirteenth year as a "nationally certified Open and Affirming faith

News From National Scene

More than 11,400 doctors and scientists have signed the **Rome Declaration** to alert citizens about the deadly consequences of Covid-19 policy makers' and medical authorities' unprecedented behavior; behavior such as denying patient access to lifesaving early treatments, disrupting the sacred, physician-patient relationship and suppressing open scientific discussion for profits and power.

Remember Bill Clinton's Attorney General Janet Reno and her **Office of Community Oriented Policing Services (COPS)**? Billions of taxpayer dollars have been given to the office since 1994 and Joe Biden's Administration just handed them another \$33 million this week! \$1.7 million will be used for the creation
