1.) Do you support expanding background checks for gun purchases?

No, I oppose this. Gov. Wolf's proposed "gun show loophole" is a misnomer. All licensed firearms dealers in Pennsylvania are already required to perform a background check. Gov. Wolf proposes to require background checks for parents who pass a gun to their children. This will not increase safety for anyone, just add additional unnecessary regulation.

2.) Would you sign into law bills such as SB 613/HB 1410 which adds "sexual orientation, gender identity or expression" to the PA Human Relations Act which impacts employment, housing and public accommodations?

No, I am the only candidate in the Republican primary who opposes this legislation. I oppose this for two reasons: 1) it compromises the security and the privacy of our children, and 2) it compromises religious freedom.

3.) Would you sign into law a "Death with Dignity Act"/Right to Die" bill, if it reached your desk?

As part of building a Culture of Life, I would not support legalizing euthanasia in Pennsylvania.

4.) Do you support banning abortions after a child in the womb can feel pain?

Yes. I am a strong supporter of SB3 and would sign that law as Governor.

5.) Do you support banning all abortions based on a Downs Syndrome diagnosis of the baby?

Yes. I support the banning of all abortions based on a Downs Syndrome diagnosis. Pennsylvania already bans abortions based on the gender of the baby. If we accept the argument that Pennsylvania should prohibit abortions for gender selection, then the argument that a Downs Syndrome diagnosis is an "acceptable justification" for an abortion is offensive. All lives have value.

6.) Do you support parental consent before a minor can get an abortion?

Yes. I support parental notification laws.

7.) Do you believe Christian bakers, florists, etc. should be forced to bake a wedding cake or produce floral arrangements, etc. for same-sex weddings?

No. The bakers in question had no problem serving all customers. The question in this case was whether they should be forced to create a custom cake. This baker also does not provide custom cakes with obscene topics, hate speech, Halloween

imagery, or anti-American cakes. I wrote an op-ed on this issue, and have attached it to this response.

8.) Do you support allowing early voting in Pennsylvania?

I do. I also support Voter ID laws and the right to cast an absentee ballot without an excuse in Pennsylvania. We all want a system that is easy to access, transparent, and one where we all have confidence in the process.

9.) Would you support the PA Department of Education if it issued guidelines to require all schools open the girls' bathroom, locker and shower facilities to boys who believe they are girls?

No. Harrisburg should not be telling people where to use the bathroom. I don't support discrimination against anyone, but as Governor, I will not support the state government compromising the privacy of our children.

10.) Do you support reversing PA's Medicaid expansion that occurred under Obamacare?

Yes. I have spent 25 years in the health care industry helping organizations navigate this complexity. In particular, I have spent the last eight years helping companies cope with Obamacare. I'm the only candidate with a plan to deal with how Tom Wolf has destroyed health care industry in Pennsylvania—one I outlined in *Restore the Dream*.

Washington will never solve Pennsylvania's problems, and the Medicaid expansion will cost us about \$500 million additionally each year going forward. We must repeal the Medicaid expansion and replace it with a system that better manages chronic care, promotes patient-centered care and cost transparency, promotes wellness and prevention, and promotes innovation.
