PA's Commonwealth Court has overturned a 2021 executive order signed by then-Mayor Jim Kenney that replaced Columbus Day in Philadelphia with Indigenous Peoples' Day.

News from National Scene

U.S. District Court Judge Nancy Brasel sided with Minnesota parents seeking to allow their children to obtain postsecondary education credits at faith-based institutions of higher education as well as Christian colleges in the state.

The US Senate in a 53-43 party-line vote invoked the so-called "nuclear option" and changed the chamber's rules to more easily confirm dozens of President Trump's stalled sub-Cabinet nominees. The Republican plan was based on one offered by Sens. Amy Klobuchar (D-Minn.) and Angus King (I-Maine) in 2023. The Republican push stemmed from Democrats'

refusal to OK any Trump nominee, even those considered uncontroversial, via unanimous consent or voice vote.

The 1st U.S. Circuit Court of Appeals put on hold a preliminary nationwide injunction by a lower-court judge that blocked the Trump administration from cutting Medicaid funding to all Planned Parenthoods.

University of **Arkansas** students returning to class have the opportunity to take a class on the "Queer U.S. South."
