They want to remove the 24hour waiting period and state-mandated counseling. They also "will work with to stakeholders develop legislation that expands access to the full range of reproductive healthcare and reflects Pennsylvania's commitment bodily to autonomy and reproductive rights."

The Republican National Committee announced that it will lead a lawsuit against the Pennsylvania over the issue of illegally "curing" ballots in elections, a process whereby election workers alter incomplete or unreadable ballots rather than treating them as the law requires.

Residents have sued the Chester County Board of Elections over drop boxes. They are asking that all thirteen drop boxes be monitored in person to

Maasas obscene for children and to restrict their distribution to minors, including by booksellers and libraries. Both books describe or illustrate sexual acts.
