News From Around PA

Recently **the PA Commission on LGBTQ Affairs** and other activist groups sent a letter to the General Assembly urging them to pass at least one of the homosexual special rights bills that have been introduced in Harrisburg -- HB 1404, SB 224 or SB 614. These would add 'sexual orientation or gender identity' to the PA Human Relations Act, which impacts employment, housing and public accommodations. The letter cites the US Supreme Court case *Bostock v Clayton County*, which redefined 'sex' in the 1964 Civil Right Act to include transgender.

The nation's largest homosexual lobby group, **the Human Rights Campaign**, has announced an addition of five new staff members, bringing the total number to 14, in their effort to turn out "Equality Voters" for the November election.

A Philadelphia 'gay' man has filed a federal lawsuit against

Guess, Inc. alleging he was wrongly accused of sexually assaulting one of his male subordinates while working as assistant store manager at a Guess clothing store in Bethlehem. As a result, he was terminated. He is seeking \$150,000 in damages

A homosexual letter carrier who worked in **Allentown** claims he was fired due to his sexual orientation and HIV-positive status. He is accused of kicking a co-worker. He has filed an antibias lawsuit, but the USPS has asked that the lawsuit be dismissed.

News From National Scene

The supermarket chain **Kroger** has been sued in federal court by two former employees who claim they were fired for refusing to wear an apron with a rainbow symbol believing that if they wore the apron it would show their advocacy for the LGBTQ agenda.

Fox 17, WZTV in Nashville, has uncovered emails that reveal there was an effort to deliberately deceive the public by withholding covid-19 infections statistics that would have shown that bars and restaurants are not spreading infections.

Senator Ted Cruz is calling for the Department of Justice to investigate Netflix for producing and distributing child porn. He is specifically concerned about their recent production of "Cuties" which sexualizes young girls.

A recent published paper in the **Journal of Family Psychology** states, "The findings suggest that the presence of two parents - or a male parent - is not essential for children to flourish."

Sarah McBride recently won the Democratic primary in Delaware's first state senate district.
