Former openly homosexual PA House member, **Brian Sims, has been named the CEO of Agenda PAC**, “a political action committee which intends to not only challenge conservatives but specifically targets queerphobic extremists.” (NOTE: Yes, they just invented a new word – queerphobic!). Last year they successfully went after Moms for Liberty school board candidates and this year are targeting several legislators across the country, including PA House members Valerie Gaydos and Joe Emrick.

The LGBTQ Center of Central PA in Harrisburg is opening a new exhibit, **“America’s First Equality Governor: Gov. Milton Shapp’s LGBTQ+ Initiatives.”** The founder of the Philadelphia Gay News, Mark Segal, collaborated with Shapp “to advance progress for LGBTQ+ people in Pennsylvania”.

The **PA Supreme Court heard oral arguments in *Glover v. Junior***, a case involving two “married” lesbians who used

IVF for one to get pregnant. They separated during the pregnancy and the one who carried the baby to term does not want the other to “co-parent”. The court will have to decide who the parents are who can raise the child. No matter how the case is decided, the child will still be the loser by not having a father in his or her life.

The **Pennsylvania Human Relations Commission** has announced the creation of civil and human rights clubs in schools across the cities of Philadelphia and Harrisburg. This new initiative will end with the students engaging in a social justice project to address a form of xenophobia and propose potential solutions to combat it.

State Rep Stephen Kinsey (D - 201) retired on July 16. A **special election was held for House District 201**, which includes parts of Germantown, East Germantown, West Oak Lane, Ogontz and Logan. Andre D. Carroll won the special election. He will be the second open homosexual serving in the State House. The other is Malcolm Kenyatta, the current Democrat

candidate for Auditor General.
