**News from Around PA**

US Senators Bob Casey, Jr. and John Fetterman want to give \$1 million taxpayer dollars to Philadelphia's **William Way LGBTQ Community Center!** While the US House Appropriations Committee rejected this earmark, the Senate is moving forward. It doesn't need our money! Its 2023 corporate sponsors include Merck, NovaCare, and Urban Outfitters. Its Trans Resource Center gets funding from Macy's and TD Charitable Foundation.

About 400 **Perkiomen High School** students in Montgomery County walked out in response to the school board failing to approve a policy that would have protected female students from having to share a bathroom with males who identify as female. The vote was 5-4 to send the policy to the Policy Committee where they all know it will die!

The in-depth report "**2024 College Free Speech Rankings**". An overall ranking of 248 schools nationwide

was produced based on the responses of over 55,000 students. The University of Pennsylvania ranked "very poor"; Penn State "below average"; Duquesne University "poor"; Drexel and Temple "average".

After Wesley Wofford, a white sculptor's, work depicting **Harriet Tubman** received rave reviews, Philly hired him to do another piece that would be on permanent display. However, public meetings were held where the choice of a white man was denounced. The city revoked his commission and started looking for a black sculptor. Harriet Tubman's ancestors have spoken out in support of Wofford, saying, "Harriet Tubman stood for people of all races".

### News From National Scene

The **Military and Religious Freedom Foundation** has threatened Fort Liberty (formerly Fort Bragg) in North Carolina with the possibility of a federal lawsuit if it doesn't remove a Christian bookstore, arguing that its existence on the base is a violation of the First Amendment.

Montana, Texas, Wyoming and Missouri have cut ties with the **American Library Association** because of their promotion of harmful books.

**All flags – including the rainbow "pride" flag** – are no longer allowed in the Sunol Glen School District and the Temecula Valley Unified School District. Only the California flag and the American flag are permitted to be displayed.

**Missouri's Attorney General Andrew Baily** successfully defended legislation that would outlaw gender surgery and hormone treatment for minors looking to "transition" from one sex to another.

**Kansas will no longer change the birth certificates** of those who identify as the opposite sex in order to reflect their gender identities the state health department said.
