News from Around PA

Five US states - California, Michigan, Pennsylvania, Minnesota, New York and New Hampshire -- have refused to show **voter rolls** proving illegal aliens have not been voting in elections. The US Attorney General's office has sued to get the rolls.

U.S. Department of Justice has served subpoenas on the **University of Pittsburgh Medical Center (UPMC) and Children's Hospital of Philadelphia (CHOP)** seeking information about the transgender youth who have received "gender-affirming care" from those facilities.

In partnership with the **Media Business Authority and the Borough of Media**, the Media Arts Council is leading the "creation of a bold new public art installation: a Pride crosswalk in the heart of our community at the intersection of State Street and Plum Street in Media".

Eight days after issuing the memorandum "**Upholding constitutional rights and parental authority in America's education system**",

the U.S. Department of Justice contacted a father regarding alleged violations of his First Amendment and due process rights by the Unionville-Chadds Ford School District (Chester County) stemming from years of being ignored at the local, state and federal levels.

Chester County Commissioners voted 2 to 1 along party lines to create a new county-level human relations commission. The ordinance includes "sexual orientation and gender identity or expression" and impacts employment, housing, and public accommodations" as protected classes.

H Res 719 **Honoring the life and legacy of Charles "Charlie" James Kirk** was passed by the US House in a vote of 310 to 58. All GOP were joined by 95 Democrats in voting 'yea'. Thirty-eight Democrats, including PA's Dwight Evans (D-PA 3) and Mary Gay Scanlon (D-PA 5), simply answered 'Present'. Congresswoman Summer Lee (D-PA 12) voted "nay".

News from National Scene

Funding has been secured for nearly 300 murals to be painted of **Iryna Zarutskya's**

face in US cities nationwide, after Elon Musk pitched in \$1M. She is the Ukrainian immigrant who was stabbed to death on a Charlotte train.

Linn-Mar High School in Marion, Iowa aired on its student-run TV program, a segment celebrating 'non-monosexual identities' for **'Bisexual Plus Awareness Week'**. The school's morning TV show began with a student reading aloud the segment from Spectrum, the school's student-led Gay-Straight Alliance club. US Rep Ashley Hinson's son attends that school and she has sent a letter to US Secretary of Education Linda McMahon calling for an investigation.

Former **Boise State University** transgender athlete, the plaintiff in the US Supreme Court case concerning men in women's sports, has asked that the case be dismissed.
