#### **News From Around PA**

##### **Shippensburg Boro Council**

(Franklin County) voted 5 to 1 to adopt a homosexual special rights ordinance which equates changeable homosexuality and transgenderism to unchangeable race and ethnicity. It impacts employment, housing and public accommodations.

All large PA cities and many smaller cities have passed **homosexual special rights ordinances** (they call them 'non-discrimination, but they target Christian business owners, landlords, day care centers, etc.). Smaller towns are now being targeted by homosexual groups and the next one they expect to cave is Gettysburg!

The **Secretaries of the Navy, the Air Force and the Army** under Obama joined the "Modern Military Association of America," an organization of LGBTQ service members, to file an amicus brief in the *Fulton v. City of Philadelphia*

case dealing with Catholic Social Services (CSS). The brief opposes CSS' religious freedom to not place children in same-sex households.

#### **News From National Scene**

**Ben & Jerry's ice cream** has announced its support for Black Lives Matter and is calling for defunding police.

A **task force formed by the Washington, DC mayor** has issued a 24 page report targeting dozens of DC landmarks saying they violate the DC Human Right Act. Schools named for Thomas Jefferson, Alexander Graham Bell and Francis Scott Key must be renamed, according to the report. It further recommended that officials "remove, relocate or contextualize" the Jefferson Memorial, Washington Monument, and statues of famous figures such as Benjamin Franklin

In response to the disastrous **Bostick vS Supreme Court ruling** which redefined 'sex' in Title IX to include 'gender identity,' the US Department of Education Office of Civil Rights has issued a statement assuring worried parents that "federal regulations allow schools to have separate-sex-

athletics 'based on biological differences.' So, according to this administration, boys who think they are girls cannot play on girls' teams.

Science fiction fans: Season 3 of "**Star Trek Discovery**" will feature its first transgender and first nonbinary characters.
