News from Around PA

The Philadelphia chapter of the **Council on American-Islamic Relations (CAIR)** announced that it is partnering with local schools to make them "more inclusive."

Montgomery County (Montco) Board of Commissioners voted on a 2-1 party-line vote, to create a human relations commission (HRC) that will handle claims of unlawful discrimination. Neither state law, nor the county resolution, explicitly carve out special protections for LGBTQ residents, but the two Democrat commissioners who voted for the HRC said the Montco commission would protect against discrimination over sexual orientation. Remember this impacts employment, housing and public accommodations.

In January 2017, Libby Hilsenrath, a Christian, discovered her 12-year-old son was **being proselytized to convert to Islam** during a mandated class in World Cultures and Geography

being taught at the Chatham Middle School in Chatham, New Jersey. She also learned that her son was required to complete a worksheet which included a fill-in-the-blank written profession of the conversion statement to become a Muslim. The school board ignored her complaints, she filed a lawsuit which ended up before the Third Circuit Court of Appeals, which sided with the school. In light of the recent US Supreme Court (SCOTUS) decision in favor of the parents in Montgomery County, Maryland, the Thomas More Law Center is appealing the Third Circuit decision to SCOTUS. (NOTE: This is not a story out of PA, however, PA is in the Third Circuit, so the decision directly impacts PA parents.)

News from National Scene

Recently **Congresswoman Rashida Tlaib** (D-MI) spoke at a "People's Conference for Palestine" saying, "Detroit taught me that the political structures we are surrounded by were built on slavery and genocide and rape and oppression. It's not the genocide-enabling Congress or the White House that will free our people. It is only us."
